

# CORPORATE PAY LATER GUIDE

This option is designed for bigger corporate teams and allows an office administrator to make a reservation and defer payment for the team. A deposit of \$1,000 is necessary for Corporate Pay Later teams. Once the deposit is successfully completed, we will send you a code via email, which can be used by your team members. An invoice will be generated before the event, taking into account the number of codes that are redeemed.

## HOW TO ACCESS THE REGISTRATION PAGE

To access the registration page, please visit perthrunningfestival.com.au and click on the 'REGISTER NOW' button on the top right-hand side of the page:





### CORPORATE TEAM CONSIDERATIONS

There are a few things which Corporate Team Captain's need to consider before getting team members to register into your team:

### 1. Deciding on your Corporate Team structure:

- Will the organisation be covering registration fees for their team members?
- If yes and you know roughly how many people will be registering for each distance/age group, then Corporate Pay Now is the best option!
- If yes, but you don't know how many people/what distance/what age group then Corporate Pay Later is the option for your team!
- Will individuals be processing payment for their own registration's? If so, then please refer to our separate Team Registration Guide.

### 2. What is your plan for bib collection?

The options for bib collection are:


- Individuals collect their own bibs during bib collection opening times (Friday 9th through Saturday 10th October)
- Individual postage (for an additional fee –by default this fee will be payable by the individuals when they register). Please note to select the postage option you must be registered by September 1st 2026.
- Corporate team courier to one address (for an additional fee –this option will only be available to teams over 50 people or larger. If you are interested in this option, then please contact the Perth Running Festival Events Team at info@perthrunningfestival.com.au)



### **CORPORATE PAY LATER**

To register for the Corporate Pay Later option, please see instructions below:

- 1. Select the 'Corporate Pay Later' option in the registration system.
- 2. Complete your details (note –these will need to be the Team Captain's details).
- 3. Create a team by selecting 'yes, create a new team and add this registrant'.
- 4. Enter your team name –think of something easy to help your team mates find you!
- Optional You can create a code as a password that team members have to enter to join the team. (Please note, this code needs to be 4 characters/digits or more).





### **CORPORATE PAY LATER**

- 6. Agree to the waiver and privacy policy.
- 7. Check over your order to finalise.
- 8. Once processed, you will automatically receive an email with your team code and further instructions. (If you would like to do the event yourself, you will also need to redeem one of these codes).

#### Please note:

- Corporate Pay Later teams need to be finalised a minimum of two weeks prior to event day, with an invoice
  issued to you pre-event based on the amount of codes that have been redeemed. The deposit amount will be
  deducted from the final invoice total. The deposit is non refundable.
- Please ensure that your promo code is shared as per your own internal policies, as invoices will be issued based off the total number of code redemptions.
- Corporate Pay Later has a deadline of 20th September 2026 at 2PM for their team members to join.




### **MANAGING YOUR TEAM**

### Please see instructions below to manage your team:

- 1. Scroll the the bottom of your confirmation email and click on the 'Claim Registration' link and create, verify and log into your Race Roster account.
- 2. Once logged into your dashboard, select the 'teams' tab
- 3. As the Team Captain, you will need to review and accept the agreements before being able to view any details of your team. Please click on 'understanding & agreements' and review and check the boxes to confirm










### **MANAGING YOUR TEAM**

- 4. Please note, your entry will be assigned as the Team Captain with your team's name
- 5. From the 'teams' tab you can;
- View the total number of team members registered
- See/copy the team entry URL
- Using the 'team actions' and as the Team Captain, you can use this function to edit and connect with your team, as well as view an export of the registered team members






## **HOW TEAM MEMBERS CAN REGISTER**

Once you're team is created please see instructions below to share with your team members so they can register!

1. Share your team referral link directly with your team members. Your team referral link can be found in your participant dashboard in the 'Teams' tab under 'Team entry URL'. Please note, if you created a team access code/password when creating the team then make sure you share this too, otherwise they won't be able to join. In the event you have forgotten / misplaced your access code you can see this in the 'Teams' tab of your participant dashboard.







## **HOW TEAM MEMBERS CAN REGISTER**

- 2. Team members will need to go through the process to create their Race Roster account, and verify their email address
- 3. Your team member can now go through the registration process to register and join your team! Remind team members to enter their Corporate Pay Later code into the 'Enter Promo Code' box at the end of Step 1 (Register) or at Step 3 (Checkout). You will have been emailed the code(s) upon completing registration for Corporate Pay Later.
